

Conference Regulations

Crisis management in the financial system– stairway to heaven or highway to hell?

§ 1. General provisions

1. These Regulations (hereinafter referred to as the "**Regulations**") define the rules for participation in the conference called "*Crisis management in the financial system - stairway to heaven or highway to hell?*" (hereinafter referred to as the "**Conference**").
2. The organizer of the Conference is the Bank Guarantee Fund with its registered office in Warsaw, Fr. Ignacego Jana Skorupki 4 Street (00-546 Warszawa), tax ID: 525-10-52-103 (hereinafter referred to as the "**Organizer**").
3. Reading the Regulations and accepting all their provisions by the Participant and receiving confirmation of participation in the Conference by the Participant from the Organizer is tantamount to concluding an agreement for participation in the Conference with the Organizer.
4. Each person who receives electronic confirmation of participation in the Conference from the Organizer is obliged to comply with the provisions of these Regulations.
5. The conference will be held on May 9-10, 2024 in Warsaw. The Organizer reserves the right to change the date of the Conference or cancel it in case of events beyond its control that prevent the Conference from being held on the date specified in these Regulations. The Organizer then bears no liability and the Participants are not entitled to any claims in this respect. The Organizer will immediately inform the Participants about the change of date or cancellation of the Conference by sending information about the change of date or cancellation of the Conference to the Participant's e-mail address provided in the registration form.
6. Participation in the conference is free of charge.
7. The abbreviations used in these Regulations have the following meanings:
 - a. Participant - every adult natural person with full legal capacity who registered for participation in the Conference, received confirmation of registration and then electronic confirmation of participation in the Conference;
 - b. Civil Code - Act of April 23, 1964 - Civil Code (consolidated text: Journal of Laws of 2023, item 1610, as amended);
 - c. Conference Website - website www.conference2024.bfg.pl.
8. The provisions of these Regulations will apply to participation in the Conference also in the event of a change of the date or place of the Conference, as well as in the event of a change of the Conference format to an online Conference.
9. The Organizer provides all information regarding the Conference by e-mail at: conference2024@bfg.pl.
10. Reading and accepting these Regulations is a necessary condition for participation in the Conference.

§ 2. Registration of participation in the Conference

1. Persons interested in participating in the Conference should register for the Conference via the registration form available on the Conference Website.
2. The Organizer is not responsible for providing incorrect or false data by the Participant when registering for the Conference.
3. Before sending the registration form, the Participant is obliged to read these Regulations. Registration is effective only if the Participant accepts the content of these Regulations.

4. Sending the registration form constitutes acceptance of the provisions of these Regulations, as well as the obligation to comply with legal provisions and any other arrangements made between the Participant and the Organizer.
5. An agreement is concluded on the terms specified in the registration form and these Regulations when the Participant receives confirmation of participation in the Conference.
6. Only adults can participate in the Conference.
7. Registration for the Conference is possible until April 5, 2024.
8. The following groups of Participants can take part in the Conference:
 - a. Listener – a person taking part in the Conference, other than the Panelist or Speaker and the Person presenting the paper;
 - b. Panelist or Speaker – a person invited by the Organizer to take part in the Conference in one of the debates or in the form of an individual speech;
 - c. Person presenting a paper – a person who submitted a proposal to present a paper accepted by the Organizer.
9. After registering for the Conference via the registration form, the person interested in participating in the Conference receives electronic confirmation of registration in the form of message to the Participant's e-mail address indicated in the registration form. Confirmation of registration does not constitute confirmation of participation in the Conference. The Organizer reserves the right to make the final decision on accepting or not accepting the Participant's application.
10. The Organizer sends confirmation of participation in the Conference to the Participants by April 15, 2024. The Participant authorizes the Organizer to send confirmation of participation in the Conference electronically to the e-mail address indicated in the registration form.
11. The Organizer reserves the right that not everyone who registered must receive confirmation of participation in the Conference. The Organizer reserves the right to refuse to allow an interested person to participate in the Conference without giving a reason.

§ 3. Organizational provisions

1. Participation in the Conference is only possible in stationary form. The Organizer reserves the right - depending on the circumstances - to change the format of the Conference to a Conference taking place entirely or partially online. The Organizer will immediately inform the Participants about the change in the formula of the Conference by sending information about the change in the formula to the Participant's e-mail address provided in the registration form.
2. The conference will be held in Warsaw at the location published on the Conference Website no later than one month before the conference date. The Organizer reserves the right to change the place of organization of the Conference. In the event of a change in the place of the Conference, the Organizer will immediately post information about the change of the Conference place on the Conference Website and inform the Participant by sending information about the change of the Conference place to the Participant's e-mail address provided in the registration form.
3. The Organizer does not cover the accommodation and travel costs of the Listeners and the Persons presenting the paper.
4. In the event of resignation from participation in the Conference, the Participant will inform the Organizer by sending information about the resignation to the Organizer's e-mail address: conference2024@bfg.pl.

§ 4. Course of the Conference and organization of the scientific part

1. The conference includes the following elements:

- a. Opening speeches – speeches by the Organizer and selected Panelists or Speakers invited by the Organizer;
 - b. Plenary and parallel debates – debates in which Panelists or Speakers invited by the Organizer take part;
 - c. Scientific sessions – sessions attended by Persons presenting a paper approved by the Organizer.
2. The detailed Conference program will be available on the Conference Website no later than 7 days before the Conference.
3. Authors interested in participating in the Conference as a Paper Presenter should send their paper proposals by March 10, 2024 to the following address: paper.conference2024@bfg.pl.
4. In order to select people participating in scientific sessions, the Organizer appoints the Scientific Council of the Conference.
5. The Scientific Council consists of people from the scientific community invited to participate in the Scientific Council by the Organizer.
6. The work of the Scientific Council is managed by the chairperson of the Scientific Council.
7. Members of the Scientific Council formulate opinions on the submitted paper proposals. The opinion should include an indication whether the member of the Scientific Council recommends or does not recommend allowing the presentation of the paper during the scientific session. Opinions are non-binding.
8. Based on the opinions received, the Organizer decides about the acceptance of the submitted paper proposals and inclusion in the scientific sessions.
9. The organizer informs the authors about the acceptance of the submitted papers by March 29, 2024.
10. The qualified author registers as a Person presenting the paper in accordance with the deadline specified in § 2 point 8, i.e. by April 5, 2024. Authors whose papers have not been accepted may register for the Conference as a Listener on the same date.
11. Upon submission of papers or any other works created in connection with the Conference to the Organizer, the author of the paper grants the Organizer a non-exclusive and free license, without territorial restrictions and for an indefinite period, to use the paper proposal and other materials submitted to the Organizer (e.g. slides presented during the Conference), as well as grants permission to disseminate his image recorded in all photographs constituting elements of the paper proposal. The license includes:
 - 1) in the field of recording and reproduction - recording and reproduction of materials using any technique, including printing, reprography and digital technology, on all types of media, including CD and semiconductor media, as well as entering and transmitting rights to the memory of ICT systems;
 - 2) in the field of distribution - rental, lending and marketing of media on which the rights are recorded;
 - 3) in terms of dissemination in a manner other than that indicated in point 2 above - making available in such a way that everyone has access to the materials at a place and time of their choosing, displaying, broadcasting and rebroadcasting, both terrestrial and satellite, transmitting materials in a streaming system, both live, as well as on request.
12. The Organizer reserves the right to change the Conference program, change Panelists, Speakers or People presenting the paper.

§ 5. Identification, security and rules of holding the Conference

1. Before entering the Conference area, each Participant receives an ID badge. Each Participant is obliged to carry an ID badge, in a visible place, throughout the Conference.
2. Possession of an ID badge by the Participant entitles to enter to the Conference and gala dinner on May 9, 2024.
3. Conference Participants are prohibited from conducting any activities or distributing any materials that are of: commercial, acquisition, advertising or promotional nature. It is also prohibited to conduct any agitating activities and money collections not agreed with the Organizer, as well as activities incompliant with applicable law.
4. The Organizer is not responsible for the Participant's belongings that may be lost, stolen or destroyed during the Conference.
5. Participants bear full financial responsibility for any damage they cause on the premises where any activities related to the Conference are carried out.
6. Participants are obliged to immediately report to the Organizer any cases of inappropriate behavior of other Participants.
7. Participants who, despite being asked to stop violating the provisions of these Regulations, do not follow the Organizer's instructions and, in particular, create a danger to other Participants by their behavior or disrupt the course of the Conference, are obliged to leave the Conference immediately and are not entitled to any claims against the Organizers in this respect.
8. The Organizer declares that the content provided during the Conference is for educational purposes only. The Organizer is not liable for any damage caused to Participants or third parties in connection with or as a result of the use by Participants of the information, knowledge or skills acquired during the Conference.
9. The Organizer informs that the course of the Conference may be filmed, photographed, broadcast and recorded on media as part of television, radio, Internet and other public broadcasts according to any current technical method.
10. Acceptance of these Regulations means in particular that if the Participant's image is recorded in connection with participation in the Conference, the Participant - pursuant to Art. 81 section 1 of the Act of February 4, 1994 on copyright and related rights (Journal of Laws of 2022, item 2509) - consents to the free use and dissemination of his image by the Organizer and any entities authorized by the Organizer, without time and territorial restrictions.
11. By deciding to participate in the conference, each Participant acknowledges that this image may be disseminated by the Organizer, among others, for the purposes of promotion and information about the Conference at any chosen place, time or form of presentation (e.g. frame, photo, film), in a broad understood media, including the Internet, social media (e.g. Facebook, Instagram, LinkedIn, YouTube), the press, and the Conference Website.
12. The above consent to use and disseminate the image covers in particular the following fields of use:
 - 1) recording on any audiovisual medium (e.g. video media, photosensitive tape, etc.)
 - 2) any reproduction by any technique, including: on audiovisual discs, photosensitive techniques, digital techniques, computer recording techniques, in a multimedia network (including the Internet),
 - 3) treatment,
 - 4) entering into computer memory, memory of another device and into a multimedia network, including the Internet,
 - 5) any dissemination, including in the form of print, digital recording, multimedia transmission,
 - 6) any trade in the original or copies on which the image was recorded - placing on the market (including using the Internet and other data transmission techniques using

- telecommunications, IT and wireless networks), lending or renting or giving the original or copies for use on the basis of another legal relationship ,
- 7) public performance, exhibition, display, reproduction, broadcasting and rebroadcasting, as well as making it publicly available in such a way that everyone can have access to it at a place and time of their choosing, in particular use on websites and social networking sites,
 - 8) use in multimedia works,
 - 9) use on various types of websites (including the Organizer's website or the Conference Website).
13. Registration or recording of the Conference by Participants, as well as dissemination of recordings, photos, publications and other materials obtained in connection with the Conference requires the prior consent of the Organizer expressed in writing under pain of nullity.
 14. The Organizer is not responsible for recording, recording or disseminating the Participant's image by other Participants or other persons.

§ 6. Intellectual property rights

1. All materials provided to the Participant and made available by the Organizer as part of the Conference, including: texts, graphics, photos, sounds, videos and other materials created as part of the Conference (works), as well as the graphic design and the selection and arrangement of content from published educational and promotional materials (hereinafter "**Materials**"), are protected by intellectual property rights , including copyrights owned by the Organizer.
2. Materials created or made available by the Organizer in connection with the Conference may be used, including printed and stored, only for non-commercial and educational purposes, along with information about the source of the Materials.
3. Any use or disposal of the Materials, other than those indicated above, e.g. for commercial purposes, requires each time the written consent of the Organizer to be null and void.
4. The Participant is obliged not to pass on the materials listened to or acquired through the Conference to third parties, and to ensure that such persons do not have access to the products listened to or acquired in a way that allows their reproduction, paid or free distribution or other use in a manner inconsistent with the scope of rights granted to the Participant.
5. If the Organizer receives information about violations, the Organizer will call on the Participant to remove the effects of the violations at the Participant's expense. If the Participant fails to comply with the Organizer's request within 10 days from the date of receipt of the request by the Participant, the Organizer may bring claims against the Participant for infringement of product rights.

§ 7. Final provisions

1. In matters not regulated in these Regulations, the relevant provisions of the Civil Code shall apply.
2. Any disputes between the Organizer and the Participant will be resolved first by settlement and then by the court competent for the Organizer's registered office, unless generally applicable provisions provide otherwise.
3. These Regulations enter into force on the day of their publication on the Conference Website.
4. The Organizer reserves the right to make changes to the Regulations. The change to the Regulations will enter into force on the date of publication of this change or new Regulations on the Conference Website. With respect to Participants who have accepted the Regulations,

the change will enter into force within 7 days from the date of informing them about the change in the Regulations to the e-mail address provided in the registration application and the lack of objection to this change in the above-mentioned deadline.

5. The provisions of these Regulations constitute an integral part of the registration for participation in the Conference and apply to all Participants.
6. If any of the provisions of the Regulations are changed or invalidated as a result of a final court decision, the remaining provisions shall remain in force.

§ 8. GDPR information clause

Pursuant to the provisions of Art. 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, OJ EU L 119 of 4/05/2016, page 1, as amended, hereinafter referred to as "GDPR"), the Organizer informs that:

1. The administrator of personal data is the Bank Guarantee Fund (Organizer) with its registered office in Warsaw at Fr. Ignacego Jana Skorupki 4 Street, 00-546 Warszawa, e-mail address: kancelaria@bfg.pl.
2. In case of any questions regarding the protection of personal data, please contact the Organizer's Data Protection Inspector by post (address for correspondence - as above) or electronically to the e-mail address iod@bfg.pl.
3. Personal data will be processed for the following purpose and on the following legal basis:
 - a. art. 6 section 1 letter b GDPR, processing is necessary for the performance of a contract to which the data subject is a party or to take action at the request of the data subject before concluding a contract in order to:
 - organization of the Conference on the terms described in these Regulations and actions taken in connection with its organization, including its proper conduct;
 - recording and publishing the image by posting reports from the Conference on websites and official social media profiles as well as in press publications and multimedia materials in accordance with these Regulations,
 - b. art. 6 section 1 letter f GDPR, processing is necessary for the purposes of legitimate interests pursued by the administrator or by a third party in order to establish, pursue or defend against claims;
 - c. art. 6 section 1 letter a GDPR in the event of consent to further processing of personal data in order to enable future contact, including receiving information about conferences and events organized by the Organizer. You have the right to withdraw consent to the processing of your personal data at any time - which does not affect the lawfulness of the processing carried out before its withdrawal.
4. The recipients of personal data will only be entities authorized to obtain personal data under the law and entities that are subcontractors of the administrator under the entrustment agreement.
5. Personal data will not be transferred to international organizations or third countries.
6. Personal data will be stored by the Organizer for the period necessary to achieve the processing purposes referred to in point 3, unless applicable law imposes an obligation on the Organizer to store them longer - in particular for archiving purposes in the public interest.
7. Providing personal data is voluntary, but necessary to conclude/perform the contract for participation in the Conference.
8. The person to whom the personal data is processed has the right to:

- a. request from the Organizer, as the personal data administrator, access to your personal data, rectification, deletion or limitation of processing;
- b. object to processing;
- c. data transfer.

These rights can be exercised by submitting an appropriate application (directly or by correspondence, including via e-mail) to the Organizer. In case of justified doubts, the Organizer may ask for additional information necessary to confirm the identity of the person submitting the application.

9. Each person whose personal data is processed has the right to lodge a complaint with the President of the Personal Data Protection Office if he or she considers that the processing of personal data violates the provisions of the GDPR.
10. Personal data will not be used for profiling or processed in the process of automated decision-making.
